The California Department of Transportation has completed the review of the following amendment to the Metropolitan Transportation Commission's (MTC) 2018/19 – 2021/22 2019 Federal Transportation Improvement Program (FTIP):

31	<p>Local and Transit Transportation Systems</p> <ul style="list-style-type: none"> This amendment modifies and adds projects that include funding from the Surface Transportation Block Grant Program, Congestion Mitigation and Air Quality Improvement Program, Low Carbon Transit Operations Program, and the Federal Transit Administration (FTA) 5339 Program.

MTC has certified that the amendment is financially constrained, does not change air quality conformity, and meets the requirements of public involvement procedures adopted by MTC.

Pursuant to the authority delegated to me by the Director of Caltrans, I approve MTC's Amendment Number 31. I also recommend that the Federal Highway Administration and FTA approve this FTIP amendment for inclusion into California's 2019 Federal Statewide Transportation Improvement Program (FSTIP). Projects included in this FTIP, in fiscal years beyond the four-year cycle of the current FSTIP, are not approved as part of this FTIP amendment and are for information only. Approval of this amendment does not constitute an eligibility determination of projects for federal funding.
