RE: Transbay Transit Center Peer Review

Dear Mayor Breed and Mayor Schaaf:

I write you to report the completion of the MTC-appointed Peer Review Panel's review of the investigations into the cause of fracture of the two girders at the Transbay Transit Center that were discovered in September 2018.

My last update, in June 2019, documented the Peer Review Panel's concurrence with TJPA's designer of record that the steel structure was ready for service. In that letter I noted that some aspects of the review would continue after the terminal's reopening. You may recall that the panel's scope of work was divided into several phases; ultimately these included the following:

- 1. Shoring capacity;
- 2. Sampling and testing plan;
- 3. Cause of failure;
- 4. Other areas impacted by the steel fractures;
- 5. Repair solution;
- 6. Search for other areas susceptible to brittle fracture; and
- 7. Review of fatigue assessment plan.

The Peer Review Panel has completed its reviews, with the conclusion from each phase documented by a letter to MTC. These letters are attached for your records. In summary, these letters state that the Peer Review Panel concurs with the cause of the fractures that was identified and the design of the repair that was used, and with the process the TJPA used to verify the rest of the steel structure was free of similar conditions that could lead to another brittle fracture.

The Peer Review Panel was not asked and does not intend to address the line of inquiry concerning which parties were responsible for the fractures, and whether the work was in compliance with code or contract provisions. Independent of that discussion, the panel believes there are lessons to be learned from what happened and that changes to code and

industry standards should be made to help avoid this type of failure in the future. These are summarized in a paper MTC will post on its website and present to the American Institute of Steel Construction, responsible for publishing widely-used standards for steel construction.

I would like to recognize the work of the Peer Review Panel, led by Chair Dr. Michael Engelhardt, in leading the peer review with the thoroughness and urgency it required.

Finally, I would like to express my gratitude for your leadership through the challenges faced by the region during the closure of the Transbay Transit Center. Your call for a process that would provide public confidence and ensure the problem was isolated gave the Peer Review Panel the mandate it needed to ensure all the necessary material was gathered and reviewed.
