Contract - Technical Assistance for FasTrak® Customer Service Center: HNTB Corporation (\$670,000)

Subject:

This item would authorize the Executive Director or designee to negotiate and enter into a contract with HNTB Corporation (HNTB) for on-call consultant services to provide technical assistance to support the FasTrak® Customer Service Center (CSC) in an amount not to exceed \$670,000 over a period ending January 1, 2025.

Background:

The FasTrak® CSC is currently operated by Conduent State & Local Solutions, Inc. (Conduent) through September 2027. Conduent provides both the CSC system and the operating staff. The CSC contract manages customer accounts, provides call answering, web services, payment and transaction processing and violation notice processing. In 2017, BATA staff began the planning process for a re-procurement of the CSC system and services and selected a consult to assist with the procurement planning. In May 2016, after a competitive procurement, the Operations Committee approved a bench of consultants through the Request for Qualifications (RFQ) for On-Call Consultant Assistance for Electronic Payment Implementation and Operations. HNTB's 2017 contract was approved by this Committee in September 2017 based on a competitive selection from the bench of consultants.

HNTB's work under this contract included support for overseeing the current CSC contractor as well as development of separate procurement documents for a back-office system and operations. In 2020 BATA staff paused the procurement efforts to focus on other program priorities and to align with the recent extension of the Conduent contract. BATA staff now recommends resuming the procurement process to ensure that a new vendor system is ready when the Conduent contract ends and is requesting approval of a new contract with HNTB under the 2020 Electronic Payments Consultant Assistant Bench. Under this bench, selection for entry into a contract with one of the pre-qualified consultants may take place by direct selection or via mini-procurement, pursuant to the terms of the solicitation governing the bench. The proposed scope of work for this new contract is to allow continuity for the significant amount of work

already completed by HNTB on the procurement. This contract would also include continuation of HNTB's assistance to BATA staff with oversight of the current CSC contractor including system and operational improvements, project deployments and new initiatives.

Next Steps:

Staff recommends entering into a contract with HNTB to provide continued support for the next CSC procurement and current contractor oversight in an amount not to exceed \$670,000. HNTB is neither a Disadvantaged Business Enterprise nor a Small Business Enterprise and has no subcontractors.

Issues:

None identified.

Recommendations:

Staff requests that this Committee authorize the Executive Director or designee to negotiate and enter into a contract with HNTB Corporation in an amount not to exceed \$670,000 to provide support for FasTrak RCSC procurement and technical support.

Contract – On- Call Asset Management Services: Benicia-Martinez and Carquinez Toll Bridges Asset Management Support: HDR Engineering, Inc. (\$960,000)

Subject:

A request for Committee approval to enter into a contract with HDR Engineering, Inc. in an amount not to exceed \$960,000 to provide asset management plans support services on the Benicia-Martinez and Carquinez bridges respectively.

Background:

On January 6, 2021, BATA issued a Request for Qualifications (RFQ) to select a panel of prequalified consulting firms to provide on-call asset management program support for the seven state-owned toll bridges ("Bridges"). In response to the RFQ, the Committee authorized a bench of six consultants to provide BATA with Asset Management Support.

On March 9, 2022, BATA issued an RFQ to the consultant bench of Asset Management Support for Benicia-Martinez and Carquinez Bridges. BATA seeks a team of subject matter experts to assist BATA and Caltrans staff with asset management. Efforts will include Life Cycle Cost Analysis, quantifying risks to inform BATA's financial decision making, compiling a state of the bridges for Benicia-Martinez and Carquinez Bridges and specialty studies to estimate remaining life of the bridges. Studies include analysis of structural steel painting, mechanical and electrical maintenance strategies, and items of importance with long span bridges. BATA intends to issue subsequent RFQs for the other BATA bridges at a later time.

Procurement Process

In response to the RFQ, staff received Statements of Qualifications (SOQs) from three consulting firms on the bench. An evaluation panel consisting of BATA and Caltrans staff reviewed the SOQs and scored them based on weighted evaluation criteria including: the firm's and key staff's knowledge, expertise, and experience; approach to completing the project; resource availability of key staff and the team's personnel; presentation, as evidenced in the written proposal; and interviews. The three firms in order, starting with the strongest, were HDR Engineering, Inc., WSP USA Inc., and Michael Baker International. Their scores were as follows:

Consultants	Overall Scoring
HDR Engineering, Inc.	89
WSP USA Inc.	84
Michael Baker International	78

After a thorough review of the SOQs and the interviews and while all three firms were qualified, HDR Engineering, Inc. was determined to be the most qualified firm, with a diverse team that brings in-depth practical experience and technical knowledge related to asset management and bridge analysis. Attachment A includes a summary of the selected firm and its project team's small business and disadvantaged business enterprise status.

Recommendation:

Staff recommends that this Committee authorize the Executive Director or her designee to negotiate and enter a contract for toll bridge asset management services on the Benicia-Martinez and Carquinez bridges, in an amount not to exceed \$960,000, with HDR Engineering, Inc; or should the Executive Director or her designee fail to reach an agreement with this top ranked firm, then with WSP USA Inc.

Contract Amendment – Dumbarton Forward Operational Improvements Project On-Call Design Services: HDR Engineering, Inc. (\$600,000)

Subject:

This item would authorize a contract amendment with HDR Engineering, Inc. (HDR) for on-call design services in an amount not to exceed \$600,000. These additional services are required to cover changes in project scope for the Dumbarton Forward Operational Improvements Project ("Project").

Background:

The State Route 84 (Dumbarton Bridge) corridor has experienced significant increased traffic congestion prior to the pandemic and is expected to return to pre-pandemic conditions in the coming years. Travel in the corridor between Interstate 880 (I-880) and U.S. Highway 101 (US 101) is heaviest in the westbound direction during the AM peak period and in the eastbound direction during the PM peak period.

In 2017, the Metropolitan Transportation Commission (MTC), in partnership with the respective county transportation authorities, transit agencies, cities/counties, and businesses, conducted a Dumbarton Forward Design Alternatives Assessment of the Dumbarton Bridge corridor to identify innovative near-term strategies to address traffic flow, increase person throughput and manage transportation demand. MTC prepared a Project Study Report-Project Development Support (PSR-PDS), which was approved by Caltrans in April 2019. Project elements in the PSR-PDS included:

- Part-time Bus-Only Lane (PTBOL) pilot
- Signalization Improvements to Bayfront Expressway Intersections
- Reconfiguration of Eastbound SR 84/Thornton Avenue Off-Ramps
- Relocation of Ardenwood Park-Ride Bus Stops
- Improvements to Operations at the Dumbarton Bridge Toll Plaza

At the completion of the Caltrans-required PSR-PDS, staff determined that BATA should fund and implement the project delivery phase, which includes environmentally clearing the project, preparing a concept of operations for the PTBOL pilot, and developing plans, specifications, and estimates to advance the project to construction.

In December 2017, after a competitive procurement, the BATA Oversight Committee authorized the Executive Director to enter into contracts with eight firms, including HDR, to provide on-call design services. On December 11, 2018, BATA issued a Request for Qualifications (RFQ) to all eight pre-qualified firms to provide design and environmental services for the Dumbarton Forward Operational Improvements Project. On February 6, 2019, this Committee authorized a contract with HDR to provide on-call design services for the Project.

While the project has made progress over the last several years, there have been significant delays due to changes to the project elements and project scope, including the elimination of some corridor improvements originally identified in the PSR-PDS, and the change from a pilot to a permanent conversion of the shoulder to a part-time bus lane. These changes have resulted in: additional engineering studies, coordination meetings, and supporting documentation; multiple revisions to the traffic analysis, design elements, and associated environmental and engineering reports required by Caltrans; and an extension of the project development timeline. As such, staff seeks an amendment to the HDR contract to cover these additional services.

Attachment A includes a summary of HDR and its project team's small business and disadvantaged business enterprise status.

Staff recommends that the Committee authorize the Executive Director or designee to negotiate and enter into a contract amendment with HDR Engineering, Inc. in an amount not to exceed \$600,000 to provide additional design services for the completion of the Project.
