Contract – Project Management and Strategic Advisor Support: West Oakland Link:

BayPac Consult Inc. (\$450,000)

### **Subject:**

Request for Committee approval to enter into a contract with BayPac Consult Inc. in an amount not to exceed \$450,000 to provide project management support services during the design phase of the West Oakland Link Project (Project).

# **Background:**

BATA requires a professional consulting firm to provide program management and advisory services during the design of the West Oakland Link Project, a new bicycle/pedestrian connection between West Oakland and the Bay Bridge Trail in Oakland. Project management activities include overseeing and implementing the West Oakland Link Design Services contract with T.Y. Lin International. The consultant would also provide design coordination with project stakeholders, advise the project team on the Caltrans project delivery process, and lead coordination with Caltrans during Plans Specifications & Estimate (PS&E).

#### **Contractor Selection Process:**

Under the 2023 Request for Qualifications (RFQ), which established the on-call Project/Program Management and Strategic Advisor Support Services Bench, twenty-eight (28) firms, including BayPac Consult Inc. (BayPac), are qualified to provide project management services to MTC and BATA. This bench may be utilized for a four-year period ending June 30, 2027. The RFQ allowed for the direct selection of on-call consultants to work on BATA projects.

Staff made a direct selection of BayPac to perform project management consultant services for the Project for an estimated cost of \$450,000 through June 30, 2026. BayPac was selected because of its unique knowledge and experience with the Project having moved it through the PA/ED phase starting in 2019 and developing the design consultant PS&E RFQ, scope of work, and consultant task order. BayPac will also provide continuity of performance as it has been providing project management support and advisory services for PS&E since June 2023 under

the 2019 On-Call Project/Program Management and Strategic Advisor Services Bench, which expires in February 2024.

Attachment A includes a summary of BayPac's small business and disadvantaged business enterprise status.

Staff recommends that the Committee authorize the Executive Director or designee to negotiate and enter into a contract with BayPac in an amount not to exceed \$450,000 to provide project management and strategic advisor support services for the West Oakland Link.
