# Contract– Ergonomic Education and Assessment Services: Performance Based Ergonomics (\$300,000)

#### Subject:

Authorization to negotiate and enter into a Contractwith Performance Based Ergonomics (PBE) to provide ergonomic education and assessment services in an amount not to exceed \$300,000, for a term of May 15, 2024, through June 30, 2027, with an option to extend for an additional two years in increments of MTCs choosing.

#### **Background:**

In 2016 MTC engaged PBE to provide employees with guidance, instruction, and equipment recommendations to aid in reducing injuries and encourage employee comfort and productivity while working. In June 2020, a purchase order was extended for an additional two years to provide a continuum of services to MTC employees, and again in 2022, as PBE was identified as the premier provider in the area. The training that the PBE team provides to MTC Staff is invaluable to ensuring a healthy and injury-free workforce. MTC's procurement policy, EDMM 352, has an exception for the services that PBA provides fall within this exception.

The PBE team has extensive qualifications, experience, and references in both public and private sectors nationwide. Additionally, PBE possesses the requisite knowledge and expertise to effectively train staff, ensuring consistent service quality. PBE is neither a Disadvantaged Business Enterprise or a Small Business Enterprise and they have no subsonsultants.

#### **Issues:**

None identified.

#### **Recommendations:**

Staff recommends that the Committee authorize the Executive Director or his designated representative to negotiate and enter a Contractwith PBE for ergonomic education and assessment services for MTC staff, in an amount not to exceed \$300,000 for the term of May 15, 2023, through June 30, 2027 with an option to extend for an additional two years in increments of MTCs choosing.
