Meeting in Brief:

Some key takeaways from the November 20th BARC Governing Board meeting included:

MTC Resolution No. 4210/Proposed ABAG/MTC merger

- Goal is to have enough feedback from joint committee to facilitate consultant selection and outline of a detailed workplan leading up to June 2016.
- By end of June, would have come to significant agreement on structuring a path forward.

The BARC Governing Board received a presentation on the Baylands Goals Update from Letitia Grenier, PhD of the San Francisco Estuary Institute (SFEI). Dr. Grenier provided and overview of the social, economic and ecosystem benefits that result from healthy Baylands. She summarized some of the win-win outcomes that would be possible with leveraging policy and funding support for projects to increase sediment supply. The Bay Restoration Authority Parcel Tax proposed for the June 2016 ballot was highlighted as one avenue to generate funding for such projects. The presentation will be made available on the BARC website.

Alexa Seville, reporting on a recent survey her firm *Four Twenty Seven* has completed with corporations, suggested that the urgency of sea level rise is not being conveyed in a way that ties in successfully with corporate value systems. There is a need for more creative and effective public engagement that is able to capture both optimism and empowerment in dealing with the impacts of climate change.

MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding is entered into as of the _____ day of ______ 2016 (the "Effective Date"), by and among the Metropolitan Transportation Commission ("MTC"), the Bay Area Regional Collaborative ("BARC"), and the three other BARC member agencies. The BARC, formerly known as the Joint Policy Committee, was established through California State Government Code 66536, 66536.1 and 66536.2 under Senate Bill 849 (Torlakson). The four member agencies of the BARC include:

- Association of Bay Area Governments ("ABAG")
- Bay Area Air Quality Management District ("BAAQMD")
- Metropolitan Transportation Commission ("MTC")
- San Francisco Bay Conservation and Development Commission ("BCDC")

This MOU will be reviewed annually at the time of the BARC Executive Director Performance Review to ensure the agreement remains satisfactory among all parties.

Recitals

- BARC was established through California State Government Code 66536, 66536.1 and 66536.2 under Senate Bill 849 (Torlakson), and is composed of the Metropolitan Transportation Commission ("MTC"), the Bay Area Air Quality Management District ("BAAQMD"), the Association of Bay Area Governments ("ABAG"), and the San Francisco Bay Conservation and Development Commission ("BCDC") which, collectively, are generally referred to as the Bay Area's four regional agencies;
- 2. BARC is a consortium of member agencies that come together to address crosscutting issues of regional significance, with the ultimate goal of improving the quality of life for all Bay Area residents;
- 3. BARC provides a mechanism through which its member agencies can learn, explore, collaborate, incubate, coordinate, and communicate policies and best practices that agency leadership can decide to advance collectively and singularly. BARC is made up of a Governing Board of member agency commission/board representatives, an Executive Directors Group, and other staff cross-agency work teams.
- 4. The BARC Executive Director serves as staff to the Governing Board and works directly with member agency Executive Directors and their staffs. The BARC Executive Director is employed by MTC upon the advice and input of the BARC Governing Board.

- 5. The BARC Executive Director is dedicated to achieving collaborative goals by guiding BARC's vision and strategy, supporting aligned activities, advancing policy, mobilizing resources, establishing shared measurement practices, and building public goodwill.
- 6. The BARC Executive Director acts as a convener to facilitate problem solving and regional coordination among the agencies and with interested parties.
- 7. BARC member agencies work with the BARC Executive Director to determine their annual contributions to support BARC's overall budget, and BARC's Governing Board then approves the budget;
- 8. To date, BARC staff have been employed by Local Government Services/Regional Government Services (LGS/RGS) via a contract between LGS/RGS and MTC.
- 9. MTC has determined that because BARC employment is considered long-term, it is no longer suitable to have BARC staff employed through LGS/RGS and, rather, BARC staff should be employed directly by MTC.
- 10. Taking into account that BARC is a consortium of member agencies working together in a collaborative fashion, with a Governing Board made up of elected and appointed representatives from each of the four member agencies Boards/Commissions, this MOU is intended to outline the details of employment for BARC staff employed by MTC but accountable to all agencies represented on the BARC Governing Board.

ARTICLE I BARC Executive Director

- A. BARC staff remuneration will continue to be supplied by its member agencies and approved by the Governing Board of BARC based upon member agencies' available resources.
- B. BARC staff will be provided appropriate office space by the BARC member agencies as approved in the BARC budget.
- C. The BARC Executive Director will continue to report to the Chair of BARC, a position selected by the BARC Governing Board biennially.
- D. As an employee of MTC, the BARC Executive Director will abide by MTC employee policies. Formal employment decisions regarding the BARC Executive Director will be made by the MTC Executive Director in consultation with the BARC Governing Board. The BARC Executive Director will be subject to an annual performance review, conducted by BARC member agency staff appointed by the BARC Chair, whose results will be discussed in closed session by the BARC Governing Board. The BARC Executive

Director is an "at-will" employee of MTC; employment of the BARC Executive Director may be terminated by MTC only after concurrence by a majority vote of the BARC Governing Board. The BARC Executive Director will supervise any subordinate BARC staff.

ARTICLE II MTC Responsibilities

- A. Salary and benefits: BARC member agencies will supply MTC with necessary and appropriate funding to enable MTC to provide agreed-upon salaries and benefits to BARC staff members.
- B. Contracting to support BARC activities: BARC staff will utilize MTC's contracting and budgeting infrastructure to prepare and execute BARC's budget, contracts, and any other necessary financial instruments.
- C. Office space and necessary equipment: MTC will provide BARC staff with the necessary equipment, meeting and office space, and other support necessary to perform their work.

BACKGROUND

Although air pollution levels throughout the region have decreased in recent decades, some communities in the Bay Area still experience higher levels of air pollution and therefore higher incidences of adverse health effects than others. The Air District's CARE Program and Clean Air Communities Initiative have sought to identify these disproportionately impacted areas and reduce local emissions and exposures. However, air pollutant concentrations remain elevated in close proximity to air pollution sources, such as near freeways, busy roadways, and large industrial facilities. Often, these areas with higher levels of air pollution are located in cities where infill development is planned to occur. High density, mixed-use and transit-oriented development is vital in order to reduce air pollution emissions from on-road vehicles, and for the region overall to attain health based ambient air quality standards and to reduce greenhouse gas emissions. However, potential exposure of sensitive populations to air pollution in these areas should be addressed early in the planning process to ensure that healthy infill development is planned appropriately in these communities.

DISCUSSION

To address the issue of "healthy infill development", Air District staff has been leading an effort to prepare a guidance document entitled, "Planning Healthy Places". The document includes detailed maps of local air pollution and recommends feasible and effective "best practices" to minimize exposure. The purpose of this guidance document is to encourage local governments to address and minimize potential local air pollution early in the land use planning process, and to provide technical tools to assist them in doing so.

Air District staff has worked with staff from ABAG, BARC, BCDC and MTC in developing the document. Air District staff has reviewed the document with local planning directors and other stakeholders and continues to meet with interested parties to receive input. Air District staff will provide BARC members an update on this effort, including information on the recommendations and tools provided for local government agencies, developers, and the general public.
